## **Re: BC Ferries**

Thank you for your letter of July 10, 2020, regarding BC Ferries.

Due to the negative financial impact that COVID-19 has had on the company, BC Ferries was planning to reduce some sailings they had been providing above the minimum levels in their service contract with the Province. These sailings were added to schedules on some minor routes as pilots based on the travel demand prior to the onset of the pandemic. I am pleased that we were able to reach an agreement with BC Ferries, so schedules for the minor routes, including Route 17 Powell River to Comox and Route 22 for Denman and Hornby will remain in place through the critical summer months.

We remain committed to reliable ferry service for coastal communities. As we move forward with Phase 3 of our <u>Restart Plan</u>, we want all our communities, no matter where they are located in the province, to have a chance to rebuild their economies.

I have taken the liberty of sharing your letter with Mark Collins, BC Ferries President and CEO, so that he is aware of your concerns about sailing cuts and your request for consultation with the Ministry of Education and local school districts.
