

# WHO ARE WE?


**Vision:** A region where healthy, local food is at the heart of community well-being.




Good Food Box Program- Outcomes-(SD 71 Students and Families made up ½ of our GFB Recipients) From April 8th, 2021- December 18th 2021; We supported approximately 200 households of SD71 students and families, with 3833 Good Food Boxes (each box is a week's worth of fresh food)!


## Good Food Box 2020 Stats

- Total "GFB units" distributed April-December 2020: 11,447 (one third of recipients are students and their families)
- Households served: 604, including 1567 people
- Waitlist 72 (From December)
- Partnered with 18 farmers, roughly \$150, 000 going to Comox Valley producers
- Partnered with School District 71, Indigenous Education, and many community agencies and organizations.

To explore and assess opportunities for regional food aggregation in the Comox Valley to supply the K-12 school system and other potential markets.



- Support infrastructure and equipment such as kitchen and cafeteria retrofits, greenhouses and gardens, and the purchase of appliances and tools.

# Next Steps-LUSH Valley and SD71

- We need more support for our 2021 Good Food Box programwhich supports our local farmers and the local Economy and our vulnerable students and families. Would the SD enter into conversations on how to get more local food into classrooms/homes for students?
- Supporting School Gardens and Food Literacy in Classrooms- We
  will run a small pilot in spring 2021 with 4 school gardens, and are
  awaiting a final report from Farm2School. Will SD71 enter into
  conversation with LUSH and other partners regarding a regional
  food literacy coordinator?
- Would SD 71 be interested in support the Coalition for Healthy School Food (LUSH Valley is a member).
