iii. Busing Presentation, Director of Operations, Ian Heselgrave

The Director of Operations gave an update on busing in general as well as when adverse weather occurs. School buses in our district transport roughly 2,500 students per day, on 30 different routes, driving 2,900 km per day. When snow or adverse weather occurs teams start at 4:30 am driving the district, which is divided into 4 quadrants. The Superintendent is contacted around 5:45 am with a recommendation. If a decision has been made to close schools, our communication and IT departments start to get the word out.

SD71 is implementing a new busing app, which will allow you to see each bus location in real time. This will start in January 2023 and should be in a full roll out by the end of the school year.

The Director of Inclusive Education, Sean Lamoureux does receive these reports, historically they reports remained with the administration at the school.



- Our Board has participated in several learning opportunities, virtually and in-person, as we continue to gather and refine the tools we need to do our best work together as governors of our District. Each member of our board has a multitude of schools, Board committees, and external committees where we represent the District and foster connections with our community. - Next week is the first opportunity for the Board Chairs to get together for a day to connect and learn. Following that, we will also be spending another day together at the Partner Liaison Meeting with our new Minister of Education and Childcare, Rachna Singh and the Superintendents and Secretary Treasurers from across BC.
- February is Black History month and we look forward to the learning opportunities that will take place in our schools.

Term: January 2023- January 2025 (with possibility of extension to a second term)

This letter is a formal request to the School District 71 Board of Directors to support the appointment of one Trustee to sit on the CVFPC for a 2-year term starting January 2023.

The purpose of the CVFPC is to help support regional, municipal and territorial governments- including School District 71 and community leaders to include food systems policy where appropriate in planning process and initiatives. The CVFPC supports best practices and advocates towards food policy and implementation in the areas of local food production, food security and food systems education for the region.

The CVFPC has been in operation since Nov 2019, initiated by a motion at the CVRD Board of Directors to support its establishment. The CVRD has provided annual funding matched by LUSH Valley funding and in-kind support. LUSH Valley will provide the coordination (hopefully shared with a member this term) and administrative support for the group.

The appointed SD 71 Trustee member would act in a liaison role, and would be expected to attend monthly meetings. This appointed member may also choose to sit on one or more additional subcommittee.
